

Constitution of the United States

Article II, Section 4

The President, Vice President and all civil officers of the United States, shall be removed from office on impeachment for, and conviction of, treason, bribery, or other high crime and misdemeanors.



VOTE TO IMPEACH

President George W. Bush, Vice President Richard B. Cheney, Secretary of Defense Donald H. Rumsfeld, and Attorney General John D. Ashcroft have committed violations and subversions of the Constitution of the United States of America in an attempt to carry out with impunity crimes against peace and humanity and war crimes and deprivations of the civil rights of the people of the United States and other nations, by assuming powers of an imperial executive unaccountable to law and usurping powers of the Congress, the Judiciary and those reserved to the people of the United States. They have:

- 1. Seized power to wage wars of aggression** in defiance of the U.S. Constitution, the U.N. Charter and the rule of law; carried out a massive assault on and occupation of Iraq, a country that was not threatening the United States, resulting in the death and maiming of tens of thousands of Iraqis, and hundreds of U.S. G.I.s.
- 2. Lied to the people of the U.S., to Congress, and to the U.N.,** providing false and deceptive rationales for war.
- 3. Ordered and directed the violent overthrow of sovereign states, disappearances, kidnappings, assassinations, summary executions, murders and torture.** "More than 3000 suspected terrorists have been arrested (by the U.S.) in many countries. And many others have met a different fate. Let's put it this way. They are no longer a problem..." [G.W. Bush, State of the Union message, February 4, 2003.]
- 4. Threatened to wage first strike nuclear war** against even non-nuclear countries, setting off a new arms race as non-nuclear nations now seek to develop nuclear arms to deter U.S. aggression or the loss of their sovereignty.
- 5. Trashed the Bill of Rights and fundamental freedoms** of the American people and others everywhere by acting to strip U.S. citizens of their constitutional and human rights; ordering indefinite detentions of citizens and noncitizens; ordering unlawful arrests, raids, and interrogations; institutionalizing racial profiling and authorizing domestic spying on persons based on their engagement in noncriminal religious and political activities.
